Package-

Packaging used in HTC U11 is entirely recyclable, furthermore, the paper pulp is made of 65% Bagasse and 35% Bamboo pulp. For such renewable material, it's 100% renewable and biodegradable. All the inks printed on the packaging are vegetable type, such as soy ink.
